## *Publishing Contract*

This agreement, dated 06/29/2009 \_\_\_\_\_, is made between **Macabre Cadaver Magazine**, herein called Publisher and Harold Knobbe \_\_\_\_\_, herein called Author, as respects “The Bone Fields of Indiana \_\_\_\_\_”, herein called the Work.

1. **Publishing Rights:** Author agrees to grant to Publisher first print rights, first world electronic rights, and non-exclusive anthology rights, to publish Author’s Work in readable (text) digital format (PDF, electronic download, disk, CD/CD-ROM, E-Book reader or similar media of presentation, excluding motion picture, television, video/DVD) on Publisher’s website, www.macabrecadaver.com, and in anthology compilations or “best of” collections in paperback or hardback form that Publisher, or any associated imprints of Publisher, may produce. All rights in the Work not specifically granted to Publisher in this agreement are reserved by Author.
2. **Payment (Electronic Issues):** No payment is made for any electronic publication of the Work and Author knowingly and willing acknowledges that Publisher makes no promises of reimbursement for the Work published in any electronic form.
3. **Author Warrantees:** Author warrants that he/she is Author and sole owner of the Work or has been assigned the rights delineated above; that it is original and contains no matter unlawful in its content, nor does it violate the rights of any third party; that the Work is not in the public domain. Author also warrants that these rights are owned or controlled by him/her without encumbrance and that Author has full power to grant the listed rights to Publisher.
  - a. If this work has been previously published in any form, Author warrants that the rights granted herein have reverted to him/her. As an addendum to this agreement, Author shall present some written memorandum documenting the reversion of the rights granted by any publishing company that may still own proprietary rights to the Work.
  - b. If a judgment is obtained against Publisher for usurping rights still controlled by a publisher or other entity than Publisher or Author, Author agrees to hold Publisher harmless and to indemnify Publisher for reasonable damages and costs. If Publisher prevails against a suing party or resolves the matter by out of court settlement, Author will not be liable to indemnify Publisher for defense and settlement costs.
4. **Copyright:** Publisher will print a copyright notice in Author’s name and, if applicable, a publication history along with the Work. Although it is not required, if copyright registration is desired, Author will be responsible for registering the copyright with the U.S. Copyright Office, including payment of any fees and the costs of preparing printed and/or electronic documentation of the work as required by the U.S. Copyright office.

5. **Electronic Format:** Publisher will code the work in HTML and PDF as needed for Web presentation but will make no changes in text or title, other than editorial corrections for spelling, grammar, and punctuation, without Author's written permission. Author's work will be archived for the life of Publisher's online publication. Author may request removal from the archives at any time by giving written notice to Macabre Cadaver, 1761 E. Shady Lane, Martinsville, Indiana 46151, or by e-mail to publisher@macabrecadaver.com, who will remove Author's Work from Publisher's Web site within one week of receipt of such notice. Works published in PDF format cannot be erased, reversed, or removed, and will remain intact the same as a printed medium.
6. **Anthologies:** Author's works may appear in an anthology produced by Publisher or subsidiary, at Publisher's discretion. If Author's Work is chosen for an anthology, Author will be notified with advance notice by Publisher by email, phone, or postal mail prior to publication.
  - a. For the rights granted to Publisher above, Author will receive no royalty payments in advance.
  - b. Author will receive a 50/50 pro rata share of the anthology's earnings, to include all income from domestic and foreign sales of the anthology, or any subsidiary rights sales income received by Publisher for this anthology within the royalty period.
  - c. From all earnings received by Publisher, fifty percent (50%) will be distributed to Authors on a pro rata basis in terms of the published word count of the Work. The distribution of royalties to Authors will take place no more than twice per year on or around the 30th day of June and the 30th day of December, assuming that royalties have been paid out by Publisher in that time frame. All other expenses must be met by Publisher from his/her royalty share.
  - d. In the event of sale of the anthology to a mass market publisher for reprint publication, Author will receive a 50/50 pro rate share of the anthology's earnings, to include all income from trade, book club, reprint, translation, and foreign sales of the anthology, or any subsidiary rights sales income received by Publisher for this Work within the royalty period.
  - e. The royalty period will continue for a length of two (2) years from the date of the original publication of the Work. After this term, any subsequent royalties will be paid to Publisher alone.
  - f. Author agrees to inform Publisher of his/her current address. If this address should change, and Author does not notify Publisher before the next payment is due, Publisher is not obligated to locate Author for purposes of payment of royalties. If Author does not notify Publisher of any change of address within one year of said change, Author forfeits future royalties to Publisher at Publisher's discretion. Publisher will make reasonable effort to locate Author before enforcing this forfeiture of royalties.
  - g. Publisher agrees to provide Author with one complimentary copy of the original edition of the anthology upon publication. If Author lives outside of the continental United States, he/she will be responsible for shipping costs.
  - h. Author agrees to inform Publisher of his/her current address. If this address should change, and Author does not notify Publisher, Publisher is not obligated to locate Author for purposes of providing Author with a copy of the anthology.
  - i. Author may purchase an unlimited number of copies directly from Publisher in any format at a fifty percent (50%) discount off of the retail price (shipping not included), for which no

royalties will be paid. Author may resell copies of the Work he/she has purchased from Publisher.

7. **Access to Records:** The Author may have access in person or by his/her agents or by power of attorney to all financial records of Publisher in regards to the anthology containing Author's Work upon presentation of a copy of this agreement to the appropriate location of said records, as determined by the Publisher. Distribution of records may be done electronically or in paper copies as agreed to by both parties at the time of the records request. The Author will allow the Publisher 60 days to respond to a properly made request.
8. **Term of contract:** Contract shall be in force from the date it is signed by all parties until 365 days from the actual release date of the first released format covered in Section I. The contract may be renewed by mutual consent for a period equal to that beginning the date of release.
9. **Promotion and Promotional materials:** Author may provide Publisher with a publicity biography and suggested blurb(s) for use on magazine, book cover, website and promotional literature. A photograph, in either digital (preferred) or hard copy, is optional. Publisher reserves the right to edit or rewrite blurb(s) as necessary for length or content.
10. **Signatures:** IN WITNESS WHEREOF, Author and Publisher have executed this agreement on the day and year below, to be effective immediately if the dates are the same, or on the date of the later signature if the dates are not the same. If either Author or Publisher have electronic signature capabilities and both agree to accept an electronic signature as valid, that electronic signature will be considered of identical weight to a handwritten signature.
